### The Department

- The number and cost of temporary or contract staff are managed at the divisional level and there is no central mechanism to capture the information requested. Answering this question would require a direct enquiry of all staff which would represent a significant diversion of resources.
- 2. Between 14 September 2015 and 31 December 2015 199 non-ongoing employees have been employed.
- 3. As at 31 December 2015 the Department of the Environment had 544 non-ongoing employees.
