# Senator Rhiannon asked:

Please provide in an excel spreadsheet or csv file, including the missing 2011 to current data:

- 1. Population estimates for each species of commercially shot macropods in each of the states, including Tasmania;
- 2. The shooting quota for each of those species, in each state, for each year
- 3. The take for each species, male and female, for each state, per year.

## Answer:

The population estimates, harvest quota, take and male/female harvest ratio for New South Wales, Queensland, South Australia and Western Australia for each year for the red kangaroo (*Macropus rufus*), the eastern (*Macropus giganteus*) and western grey kangaroos (*Macropus fuliginosus*) and the common wallaroo or euro (*Macropus robustus*) are at <u>Attachment A</u>.

## <u>Tasmania</u>

- The commercial harvest of wallabies in Tasmania is based upon the surveyed density of wallabies per square kilometre in the commercial harvest zones. There is no overall population estimate.
- Wallaby species in Tasmania are harvested under three small-scale wildlife trade operations. An approved quota is set for the life of each individual wildlife trade operation.
- The combined annual harvest quota for the three operations is 200 000. The wallaby species harvested under these wildlife trade operations are the Bennett's wallaby (*Macropus rufogriseus*) and Rufous wallaby (*Thylogale billardierii*).
- The Department does not have the annual take figures or data relating to the male to female harvest ratio of wallabies in Tasmania.

## <u>Victoria</u>

- There is no kangaroo population estimate for Victoria. For the Victorian pet food trial, which finishes on 31 March 2016, the Victorian Government used ten years of annual noncommercial harvest data in the two pet food trial regions.
- There are three small-scale kangaroo wildlife trade operations that have a combined quota during the Victorian pet food trial of 16 000 kangaroos.
- The Department does not have the annual take figures or data relating to the male to female harvest ratio of kangaroos taken in Victoria.

Quotas are based on the prior year's population estimates. Population estimates are based on aerial and ground surveys and are for the areas within Australia where commercial harvesting occurs. The actual national populations would be significantly higher as these figures do not include estimates for areas not surveyed.

The purpose of the special quota is to provide for the commercial utilisation of kangaroos that would have otherwise been shot under the normal non-commercial licensing system and left in the field. Special quotas are only allocated when the state management agency has determined that there is a need.
