- 1. 4826 have been issued as at 30 March 2017. The vast majority of these are iPhones (approx. 96%) with a small number of phones from other manufacturers such as Nexus.
- 2. 1078
 - (a) \$1,016,542.00
- 3. & 4. 131 phones needed to be replaced for a variety of reasons including some being lost, stolen or damaged. The cost was \$131,182.
- 5. 805 as at 30 March 2017. The vast majority of these (99%) are iPads.
- 6. 155
- 7. \$148,295.00
- 8. & 9. Twenty tablets needed to be replaced for a variety of reasons, including being damaged, stolen or lost. Total cost came to \$18,530.00
