- 1. For the past three financial years, please show what percentage of programming expenditure for each broadcaster was on New Zealand content:
 - (a) Australian adult drama
 - (b) Australian children's drama
 - (c) Australian children's other
 - (d) Australian documentaries
 - (e) Australian light entertainment- Variety
 - (f) Australian light entertainment other
- 2. For the past three financial years, please show what percentage of total hours for each broadcaster was made up of New Zealand content for:
 - (a) Australian adult drama
 - (b) Australian children's drama
 - (c) Australian children's other
 - (d) Australian documentaries
 - (e) Australian light entertainment- Variety
 - (f) Australian light entertainment other.

Answer:

1. This information is not collected by the Australian Communications and Media Authority (the ACMA).

Although some programming expenditure information is provided in the Broadcast Licence Fee returns submitted to the ACMA by commercial television broadcasting licensees, no distinction is drawn in those returns between programming expenditure referable to content of Australian origin and programming expenditure referable to content of New Zealand origin.

2. This information is not collected by the ACMA.

The ACMA does collect and publish information about the relative percentages of content of Australian origin and content of New Zealand origin broadcast by metropolitan commercial television broadcasting licensees in order to comply with the transmission sub-quotas in the *Broadcasting Services (Australian Content) Standard 2016*. This corresponds to categories (a) – (d) of question two.
