#### **Answer:**

- 1. The MyPost Digital Mailbox capability forms part of our continued investment to better support, and improve, experiences for customers across our entire suite of digital products and solutions. Today the MyPost Digital Mailbox allows customers to receive and pay bills, and to receive and store important communications. There are 1.4 million mailboxes registered with 90 live providers. Australia Post has commenced a program of work to develop some new features for our MyPost Digital Mailbox.
- 2. Australia Post is upgrading the MyPost Digital Mailbox technical platform to support new features and enhancements. The improvements will make it easier for customers to receive and pay their bills, and when managing and storing important communications.

- 4. The MyPost Digital Mailbox has been developed and funded entirely by Australia Post.
- 5. MyGov and all of their represented agencies utilise MyPost Digital Mailbox, in addition to Western Australia Police, Northern Territory Motor Vehicle Registry, and Queensland Department of Agriculture and Fisheries.

During the 2015/16 financial year, approximately \$23 million of operating costs were incurred on the digital mailbox, which includes costs of development and operational commercialisation.
