Answer:

There have been a number of public comment periods associated with Commonwealth marine reserves, including those received as part of the independent Commonwealth Marine Reserves Review and those received as part of the 'notice of intent' period (which is the first of two statutory consultation periods required under the *Environment Protection and Biodiversity Conservation Act 1999* prior to finalising Commonwealth reserves management plans):

- Comments received as part of the review—all public submissions are publicly available, except those that requested confidentiality, at: www.environment.gov.au/marinereservesreview/written-submissions
- Comments received as part of the 'notice of intent' period—the 54,322 submissions received were not made publicly available due to privacy and commercial-in-confidence information that may have been provided to the Director. The Director will however prepare a summary report on issues raised through the consultation period that will be publicly available during the next phase of consultation.
