Senator Waters asked:

Senator WATERS: Great. Can you provide on notice if they specifically discuss the interaction between those two plans. I want to move to some NRS properties in Western Australia. Can you give me the number and the names of the NRS acquisition projects that have been completed in WA but have not yet been formally gazetted as a protected area? **Ms Campbell:** I do not have that detail here, but we can take that on notice.

Senator WATERS: Thank you. I am interested in whether the provision of CfoC or NHT funding to acquire those properties to include them on the NRS had as a condition the requirement to covenant them or otherwise protect them. My understanding is that they normally do. Can you take on notice whether the contracts for the properties that have not yet been gazetted have that clause and, if so, why it has not been complied with?

Ms Campbell: We can take that on notice. Most of the contracts would have some caveat, as you indicated.

Answer:

In Western Australia, there are 53 freehold properties or pastoral leases that have been acquired with the assistance of Australian Government NRS programme funding where the process is still underway for formal declaration or the placement of covenants, consistent with the relevant funding agreement.

The processes for formal declaration or covenanting of an area are complex and different in each state. These processes can take time to work through, as issues such as Native Title applications, leasehold tenure requirements or land exploration rights may need to be reconciled before declaration can occur. This often requires careful consultation across multiple government agencies and other key stakeholders.
