The subscriptions are to ensure the company can track relevant public developments, business news and industry commentary. During the period 1 June 2014 to 20 November 2014 expenditure was \$8,857.04 (GST inclusive). NBN Co does not provide newspapers to its Shareholder Ministers or their offices.
- 3. a) to d). There is no central repository for magazine subscriptions alone. Individuals are able to order periodicals relevant to their work via their expenses. NBN Co does not provide magazine to its Shareholder Ministers or their offices.
- 4. a) to d). There is no central repository for publications alone. Individuals are able to order publications relevant to their work via their expenses. NBN Co does not provide any subscriptions to the Minister or the Minister's office.
