The ACMA manages Australian input into the setting of international standards for radiocommunications (except so far as Standards Australia International Limited is responsible for managing that input).

During the reporting period 1 June 2014 to 31 October 2014, the ACMA convened a number of meetings to assist in its role in developing Australian positions as part of key preparatory work for the International Telecommunication Union (ITU) World Radiocommunication Conference 2015 (WRC-15), to be held in Geneva from 2-27 November 2015.
