Richard Bean (ACMA Deputy Chair) is the ACMA representative on the Communications portfolio deregulation working group, and is responsible for managing the ACMA response to the government's red tape reduction targets.

There is no formal deregulation unit, with the work undertaken by each Division in the ACMA, working in conjunction with relevant areas in the Department to identify opportunities to reduce or remove unnecessary red tape.

1.1 What is the progress of that red tape reduction target

The communications portfolio has met its red tape reduction target, with the ACMA removing close to 3000 pages of redundant regulation in the media and communications sector.

Staff across a number of areas of the ACMA contribute to red tape reduction-related activities along with their other usual activities.

No additional staff have been recruited to undertake deregulatory work in the ACMA.
