Senator Ludwig asked:

Since Budget Estimates in June, 2014:

- 2. How many consultancies are planned for this calendar year? Have these been published in your Annual Procurement Plan (APP) on the AusTender website and if not why not? In each case please identify the subject matter, duration, cost and method of procurement as above, and the name of the consultant if known.
- 3. Have any consultancies not gone out for tender?
 - 1. List each, including name, cost and purpose
 - 2. If so, why?

Answer:

- 1. The ACMA undertook 6 consultancies from 1 June 2014. Details are included in the attached table.
- 2. There are no planned consultancies for the remainder of this calendar (2015). As there are no planned consultancies above the reporting threshold there are no entries for consultancies in the Annual Procurement Plan.
- 3. Three consultancy advices were obtained via limited source procurement. These were:
 - 1. Legal advice on code of conduct review including conferencing and review of entitlements;
 - Conducting an ACMA stakeholder satisfaction survey and;
 - The provision of legal advice on insolvency relating to Savvy Communications.
 - 2. Consistent with Commonwealth Procurement Rules, all three consultancies were under the \$10,000 threshold requirement for tender.
