- 2. Total expenses for newspaper subscriptions from 1 May 2014 31 October 2014, excluding the Minister's/Parliamentary Secretary's office, were \$8,193.36 (GST excl.).
- 3. The Minister's/Parliamentary Secretary's office subscribes to four newspapers, both in online and non-online formats. The Sydney Morning Herald, The Australian, The Australian Financial Review and The Daily Telegraph.
- 4. Total expenses for newspaper subscriptions from 1 May 2014 31 October 2014 were \$6,314.48 (GST excl).
