- 2. Yes. As outlined on pages 19 and 20 of the Department's *Regulatory cost savings under the One-Stop Shop for environmental approvals*, causes of delay were grouped into the following three categories:
 - the expected timeframe for an approval decision by the Australian Government after a state or territory approval, typically 30-40 business days (Part A);
 - extensions by the Australian Government to the expected timeframe, for example to obtain more information on Matters of National Environmental Significance or for more time to consider information (Part B); and
 - a late decision by the Australian Government (Part C).
