Senator Urquhart, Anne asked:

- 1. How much money was spent on consultants in the last financial year?
- 2. How many consultants were engaged?
- 3. What services were provided and how much was spent on each type of service?
- 4. Could you provide more detailed information on the ten most expensive consultancy projects including the service provided, the value and outcomes of the consultancy?
- 5. How much was spent on consultancies directed towards the strategy and implementation of funding cuts?
- 6. Does the ABC have any internal policies to guide the use of consultants?
- 7. Are there any requirements to consider whether work could be completed by existing staff before hiring external consultants?
- 8. What post-consultancy analysis is undertaken on the value for money achieved from consultancies?

Answer:

- 1. The ABC spent \$4.72 million on consultancies in the 2014-15 financial year.
- 2. The ABC engaged 115 consultants.
- 3. Appendix 9 of the ABC's 2015 Annual Report includes a breakdown of consultancy spend by vendor.

These can be broadly categorised as follows:

- 7. Yes. Consultants are engaged when specialist expert advice or services is required for a limited duration or for a specific purpose. These include advice on specific policy, technical and professional matters, specialist research projects, strategic management reviews, probity audits, audience related surveys, investigations and specialist legal, financial and property related advice and services. The engagement of consultants is undertaken in accordance with the ABC's Procurement policies and procedures and agreements and contracts are subject to authorised delegations, in accordance with the ABC's Delegations policies and procedures.
