533. The AOFM purchased a DeLonghi Nespresso Coffee machine (EN680M) on 16 December 2011. The following list provides all the expenditures related to the coffee machine since then:

250*Mixed Coffee capsules & display box	13/08/2012	\$239

- a. The AOFM purchased a new coffee machine for internal catering such as Board meetings and in-house training.
- b. There has not been a noticeable difference in staff productivity since coffee machines were purchased.
 - I. The coffee machine is mainly used for board meetings or in-house training events and not for general coffee consumption by staff.
