- 1438. Since 14 September 2015, four new Government-commissioned reviews have commenced. (Two reviews commenced prior to 14 September 2015, on Migrant Intake Into Australia and Australia's Intellectual Property Arrangements, are due to be completed in April 2016 and August 2016 respectively see response to SBT 1094-1101). Details on three main current supporting research projects is provided in the response to the questions on self-initiated work at AET 2786-2792.

Since 14 September 2015, Government commissioned reviews have been completed on Mutual Recognition Schemes; Service Exports; Business Set-up, Transfer and Closure; the Workplace Relations Framework; and Public Sector Mobile Broadband. In addition, Commission self-initiated research reports have been published on: Housing Decisions of Older Australians; and Tax and Transfer Incidence in Australia. - 1443. Each of the reports referred to in AET 1142 have been published.
- 1444. The Commission does not have information on the timing of Government responses to its reports.
- 1445. The planning of reviews is a matter for Government. All Commission reports are released publicly. For commissioned studies, release occurs at the end of the review. For public inquiries, final reports are tabled within 25 sitting days in both houses of Parliament, as required by the *Productivity Commission Act 1998*.
