AET 2582: Total legal costs incurred by the ACNC from 14 September 2015 to 29 February 2016 for external legal advice: \$36,392.13

Total legal costs incurred for internal legal advice: \$257,431. This cost represents four FTE lawyers and one lawyer at part time hours (0.87 FTE).
