Senators LUDWIG/WONG asked:

Since the change of Prime Minister on 14 September, 2015:

- 1. List all legal costs incurred by the department or agency.
- 2. List the total cost for these items, broken down by source of legal advice, hours retained or taken to prepare the advice and the level of counsel used in preparing the advice, whether the advice was internal or external.
- 3. List cost spend briefing Counsel, broken down by hours spend briefing, whether it was direct or indirect briefing, the gender ratio of Counsel, how each Counsel was engaged (departmental, ministerial).
- 4. How was each piece of advice procured? Detail the method of identifying legal advice?

Answer:

1. ASIC's approximate legal costs for the period are as follows:

Counsel's fees 4,655,319 (1 September 2015 to 29 February 2016)
External solicitors 1,924,037 (1 September 2015 to 29 February 2016)

Internal legal 28,870,673 (see note 1) (14 September 2015 to 16 March 2016)

2. See above. ASIC's preference is to first seek advice from its in-house legal service providers on all of its regulatory and operational legal work. ASIC briefs external counsel for all of its substantial regulatory litigation.

In order to provide details of the hours retained or taken to prepare the advice, we would need to review all the memorandum of costs provided to ASIC in each matter, which would involve significant resources.

3. See above. Of briefs to counsel, 61% were to males and 39% to females. All of the briefs were direct and were engagements by ASIC. ASIC does not operate on a fully integrated time costing basis, and accordingly to obtain details of the time spent by staff, and therefore the cost of, briefing counsel were involve significant resources.

4. All engagements of counsel are conducted pursuant to the requirements of the *Legal Services Directions 2005* and the *Public Governance, Performance and Accountability Act 2013*. These include the requirement to make proper use and management of Commonwealth resources (s.15 PGPA Act) and to engage counsel at their Commonwealth Approved Rates set by the Office of Legal Services Co-ordination within the Attorney General's Department.

Engagements of external solicitors after 1 July 2013 were procured in accordance with the requirements of the Legal Services Multi-use list – a Commonwealth Government-wide panel of legal services providers which all Commonwealth agencies are required to use.

ANAO Better Practice Guide: "Legal Services Arrangements in Australia Government
Agencies" (August 2006).
