Office (ATO) staff throughout Australia. Total domestic flight expenditure for the financial year to date as at 31 May 2013 is \$49,499. Total international flight expenditure for the financial year to date as at 31 May 2013 is \$9,087. The agency's travel is arranged by the Department of Treasury under a service level agreement. The Treasury advised that its reporting system is unable to break down classes of travel. As at 31 May 2013, total travel allowance expenditure for domestic is \$15,886 and international \$3,711. Whole-of-Australian-Government (WoAG) and Travel Management charges for the financial year to date is \$1,146.
