- 551. For departments/agencies that provide mobile phones to Ministers and/or Parliamentary Secretaries and/or their offices, what type of mobile phone is provided and what are the costs?
- 552. For departments/agencies that provide electronic equipment to Ministers and/or Parliamentary Secretaries and/or their offices, what are the ongoing costs for this financial year to date?
- 553. Is electronic equipment (such as iPads, laptops, wireless cards, vasco tokens, Blackberries, mobile phones (list type if relevant), thumb drives) provided to department/agency staff? If yes, provide details of what is provided, the purchase cost, the ongoing cost and a breakdown of what staff and staff classification receives it.
- 554 Does the department/agency provide their Ministers and/or Parliamentary Secretaries and/or their offices with any electronic equipment? If yes, provide details of what is provided, the cost and to whom it is provided.

Answer:

- 551. Nil. ASIC does not provide mobile phones to Ministers, Parliamentary Secretaries or their offices.
- 552. Nil. ASIC does not provide electronic equipment to Ministers, Parliamentary Secretaries or their offices.
- 553. Yes. ASIC's policy is to provide electronic equipment to selected staff, based on need and on manager's approval, and in some cases Senior Executive approval. ASIC can provide the following to agency staff:
 - o Mobile phone
 - Nokia C5 (\$237 purchase cost + \$12 per month). Available to staff with a justified and approved need.

- o iPhone
 - iPhone5 (\$799 purchase cost + \$52 per month). Available to staff with a justified and approved need.
- o Blackberry
 - Blackberry 9900 (\$567 purchase cost + \$51 per month). Available to staff with a justified and approved need.
- o Laptop
 - The purchase cost via the AGIMO panel is \$1560 for HP 2533T or \$2897 for HP2530 with no ongoing costs. Available to Executive Level 2 staff and above if justified.
- o Vasco tokens
 - The purchase cost is \$150 for hard tokens and \$140 for soft tokens, with no
 ongoing cost. Provided to staff with a justified and approved need to have
 remote access.
- USB Thumb drives
 - The purchase cost is \$55 per device. Available to staff with a justified and approved need.
