The CEFC does not lease any equipment. All equipment owned by the CEFC is located in either the Brisbane or Sydney offices of the Corporation, other than laptops which are in the possession of CEFC staff and are taken out of the office regularly in the course of the employees completing their role and function for the CEFC and backup drives which are stored off-site in accord with good business practice. With regards to accessing equipment, there are potentially many millions of computers that are accessible by the CEFC through the internet. The CEFC does back up data to hardware that is located off-site from either office for purposes of data security. The CEFC also heavily utilises video conferencing equipment in both its offices that have the potential to access computers hosting video conferencing systems at various other businesses (e.g. our customers, banks we are working with, etc) as a means of establishing the video communication connection. The CEFC's telephony system is an IP voice system that, while hosted on site in the Brisbane office, accesses computer hardware at a third party provider site to convert data to voice and connect to the POT (plain old telephone) system for incoming and outgoing calls, other than between the CEFC's own offices.

- For laptop computers: Windows 7. The contractual arrangements for operating software are through centralised Australian Government procurement.
- The CEFC is part of the whole of government procurement arrangements in relation to the purchase and ongoing support of operating systems for computer hardware. Questions in relation to the ongoing cost of support and maintenance for operating system software would be best directed to the Department of Finance who are responsible for negotiating the whole of government software procurement arrangements.
