Senator SIEWERT: How many organisations would you have that are registered under C(ATSI) Act?

Senator SIEWERT: There is a large number registered as charities that are also registered under the C(ATSI) Act. Can you also take on notice the nature of those organisations—whether they are PBCs and so on? How many organisations do you have registered now?

# Number of charities registered under CATSI Act

As at 30 June 2015, there are 789 charities registered with the Australian Charities and Notfor-profits Commission (ACNC) that are also registered with the Office of the Registrar of Indigenous Corporations (ORIC) under the *Corporations (Aboriginal and Torres Strait Islander) Act* 2006 (the CATSI Act).

### Prescribed Bodies Corporate

Of the 786 charities registered with both the ACNC and ORIC, 35 are prescribed bodies corporate (PBC).

### Subtypes of charities registered under the CATSI Act

The table below notes the subtypes held by the 789 charities registered under the CATSI Act.

# **ACNC** registered charities

The ACNC Charity Register has 54,494 charities listed on it.

Since the establishment of the ACNC, we have revoked or removed from the Charity Register approximately 9,000 charities. These charities were revoked/removed from the Charity Register as they failed to submit an Annual Information Statement for two consecutive years, or were no longer operating.

The ACNC revoked/removed these charities from the Charity Register to ensure members of the public and donors have access to an accurate and up-to-date register of charities.

In the same period we have registered over 6,000 new charities.
