Mr Schwager: The total commitment at the moment for this campaign is about \$11 million—just over \$11 million. I would also just caveat that, that \$8.1 million of that is a media buy. As I mentioned before, a media buy is a fairly flexible commitment. Senator KETTER: Could you give me the breakdown of the \$8.1 million? What forms of advertising are we talking about? MS Cook: We can give you a breakdown of components of that buy, which is an advertising media buy: advertising production costs, market research and Indigenous and culturally and linguistically diverse audience consultants. But I think we would have to take the breakdown on notice. Senator KETTER: Okay. So you are not able to tell me what proportion of it is devoted to TV, radio et cetera? MS Cook: At the moment I think I would have to take that on notice. Senator KETTER: Can you tell me about the balance of the \$11 million? You have \$8.1 million, which is your media buy, and the remaining funding allocated was \$11 million in total. Ms Cook: Some of the committed costs at the moment would be: research services, evaluation, market research, creative services, media buy et cetera. 				Senator KETTER: On 18 February, Minister Pyne issued a press release stating that the government had initiated the second stage of its antidumping reforms, which included asking the Anti-Dumping Commission to report on the impact of Asian steelmakers on the Australian market. During the Senate inquiry on the steel industry, the Anti-Dumping Commissioner told the committee that the report was given to the minister on 4 April. Is that correct?
