In his opening statement, Mr Medcraft stated that in the 12 months to May 2017, "ASIC obtained over \$804 million in compensation, remediation or returns of investor funds and over \$9.7 million in fines, penalties or infringement notices." Could a breakdown be provided of the institution/persons involved, and the matters in relation to which the amounts were paid.
