The reason for travel is the transportation of ACCC officers, management and staff to business meetings and events.

- 364. The ACCC's operational guidelines for travel designate economy class as the standard class of travel within Australia. SES may travel business class, as per entitlement, but are encouraged to consider travelling in economy on flights between Sydney and Canberra or other short single leg flights. There has been a reduction in business flights.
 - This is in line with the Finance circular No. 2012/04 in the use of the Lowest Practical Fare (LPF) for Official Domestic Air Travel.
- 365. Yes. The ACCC pays the lounge membership for 10 SES employees and 7 non SES employees. Membership has been provided where staff are required to undertake significant travel. Memberships are with the Qantas Club. Total annual cost is \$4,930.
 - Membership to the Virgin lounge is offered free of charge under the Gold Accelerator Program. The ACCC has 25 employees utilising this program.
