Total domestic flight expenditure for the financial year to date as at 30 November 2013 is \$19,586. Total international flight expenditure for the financial year to date as at 30 November 2013 is nil. The agency's travel is arranged by the Department of Treasury under a service level agreement. The Treasury advised that its reporting system is unable to break down classes of travel. As at 30 November 2013, total travel allowance expenditure for domestic is \$5,240 and international is nil. Whole-of-Australian Government (WoAG) and Travel Management charges for the financial year to date is \$433.
