The Commission does not record travel data in a way that would readily allow an answer to be provided in relation to type of airfare. To attempt to provide a greater level of detail would involve an unreasonable diversion of agency resources.

Travel was undertaken to meet business operational requirements.

- 418-419. Planned travel is undertaken and approved by the delegate on a trip by trip basis.
- 420. Statutory office holders have an entitlement to business class travel under a Determination made by the Remuneration Tribunal, but may choose a lower class fare; SES employees generally fly economy class, but may travel business class depending on circumstances with a judgment being made on a trip by trip basis; non-SES employees travel economy class.
- 421. Yes, one lounge membership is available to senior employees who are frequent travellers as part of their terms and conditions of employment. As at 30 November 2013, there are 19 Qantas Lounge memberships. The cost of an annual membership 30 November 2013 was \$355 (GST inclusive).
