ANSWER

- 1. The department owns 14 vehicles as at 31 October 2014.

- 6. The Department leases 148 vehicles as at 31 October 2014.
- 7. The Department's leased vehicles are located in each State and Territory in Australia.
- 8. The Department's fleet consists of 75 National Trade Measurement vehicles and 34 pool vehicles which are used for the transportation of equipment for field work, for the collection and delivery of goods and for travel to remote locations. In addition there are 17 AusIndustry Regional Manager vehicles and 22 Executive Scheme Vehicles (SES officers).
- 9-10. The total cost of the 148 leased vehicles from 1 July to 31 October 2014 was \$805,585. The total kilometres travelled by the leased vehicles were approximately 764,906 kilometres. To provide this data on an individual vehicle basis would be a significant diversion of departmental resources.
