Answer:

- 1774. ASIC administers the Assetless Administration Fund ("AAF"), which is a discretionary grant scheme. Guidelines in place to administer grants are set out in Regulatory Guide 109 'Assetless Administration Fund' and Regulatory Guide 242 'ASIC's power to wind up abandoned companies'.
- 1775. Details on how to apply for AAF grants are set out in Regulatory Guide 109. Applications for AAF grants are lodged via the ASIC portal.

- 1776. Yes, recipients eligible to receive funding are Registered Liquidators of companies in Liquidation.
- 1777. The application must meet the AAF criteria set out in Regulatory Guide 109. If the application meets the requirements/funding criteria via the assessment processes, funding will be approved.
- 1778. ASIC is responsible for determining whether or not the application meets the selection criteria.
