#### 1985.

- a. The ATO does not subscribe to pay TV. However, the ATO does subscribe to the Parliamentary Network. There has been no change for the Parliamentary Network subscription since the last Senate Estimates questions on notice response in June 2014.
- b. The cost for the subscription to the Parliamentary Network for the period 1 June to 31 October 2014 is \$2,906 (GST exclusive). The annual cost for the subscription to the Parliamentary Network for 2014-15 is \$7,015 (GST exclusive).
- c. The ATO does not provide pay TV subscriptions for the Minister or their office.
- d. Not applicable.

#### 1986.

- a. The ATO subscribes to a range of hard copy magazines, newspapers and journals. These subscriptions are primarily business and/or industry focused. The ATO's financial management information system does not separately identify these costs by publication.
- b. For the period 1 June to 31 October 2014, expenditure on hard copy magazines, newspapers and publications for the ATO (including the Australian Charities and Notfor-profits Commission, Australian Valuation Office, Australian Business Register and Tax Practitioners Board) was \$94,545 (exclusive of GST).
