Answer:

2103 – 2105 Legal costs incurred by the Corporation since Budget Estimates in June 2014 are summarised below:

Internal Costs: \$696,116.33 and includes base salaries plus all on costs (e.g. other compensation including superannuation, annual and long-service leave, workers compensation, etc.) for 8.2 FTE legal staff. These staff form part of the deal teams or risk management and compliance and their costs with respect to individual advices are not tracked separately.

External Costs: A summary of external costs is outlined below.
