Supplementary Budget Estimates 2015 - 2016

- 1510. For the period 1 January 2015 to 30 October 2015, the AOFM spent \$7,259 on legal services provided by the Australian Government Solicitor for advice on the issuance of new Regulation for the *Commonwealth Inscribed Stock Act 1911* and *Loans Securities Act 1919*, delegations under the *Public Governance, Performance and Accountability Act 2013*, and HR matters. For the same period the AOFM spent \$117,812 on legal services provided by a private legal firm, Herbert Smith Freehills Pty Ltd. This comprised a probity review and advice related to divestment of holding in Residential Mortgage Backed Securities and advice relating to obtaining a taxation ruling for the transmutation of stock. All legal costs were done on a time and materials basis, at an agreed rate, and billed accordingly.
- 1511. Nil.
- 1512. Legal advice obtained from the Australian Government Solicitor was on a limited tender basis. Other legal advice was via the Legal Services Multi User Listing. The legal costs for all legal advice obtained by the AOFM was done on a time and materials basis at an agreed rate and billed accordingly.
