Question

Activity Test Exemptions for domestic violence

"1. I refer to QON Budget Estimates 2013-2014, Employment, DEEWR Question No. EW0149_14. The table provided an update of Parenting Payment recipients with activity test exemptions. Please provide an update of these exemptions.

2. Please provide a breakdown of the exemption grouped together under personal circumstances. It notes that 166 of those on Parenting Payment Single have exemptions around sorry business, homelessness, witness protection, Indigenous cultural business or domestic violence. It further notes that less than 20 women on either the Parenting Payment Partnered or Parenting Partnered Single - were accessing domestic violence exemption that were available for Principal Carer Parents.

3. Please provide a breakdown of the past decade into the granting of these DV exemptions, and whether take-up increased at a result of measures that took effect after the 2010 Participation Taskforce. "

Answer

1. Of the previously grandfathered Parenting Payment Partnered (PPP) and Parenting Payment Single (PPS) recipients who transitioned to Newstart Allowance on 1 January 2013, there were 3,632 job seekers still on Newstart Allowance as at 27 February 2015 with current exemptions (843 formerly PPP and 2,789 formerly PPS). Table 1 below provides a breakdown of those job seekers by exemption category (noting the numbers include recipients whose youngest child turned 16 between 1 January 2013 and 27 February 2015 and therefore would have been transferred to Newstart Allowance from that date, regardless of the removal of the grandfathered measure).

2. As at 27 February 2015, there were <20 former PPP recipients and <20 former PPS recipients who were accessing the domestic violence exemption for Principal Carer Parents, and <20 former PPP recipients and 90 former PPS recipients with a current exemption for 'major personal crisis' (includes exemptions granted for homelessness, witness protection, domestic violence for non-Principal Carer Parents, indigenous job seeker undertaking cultural or sorry business - no further breakdown is available).

3. Table 2 below provides annual time series data on the number of Principal Carer Parents on Activity Tested Income Support Payments (Newstart Allowance, PPS, PPP or Youth Allowance (Other)) with a current exemption type of 'domestic violence', 'major personal crisis' or 'relationship breakdown'. Numbers of Principal Carer Parents with these exemption types appear to have increased moderately since end June 2008 (earliest available data). While it is not possible to attribute these increases to any particular factor/(s), they are broadly in line with rate of growth in the Activity Tested job seeker population.
