1)

- a) The Department of Education and Training pay TV subscription is the Foxtel Business Package, comprising Sky News, Sky Business and Australian Public Affairs (APAC) channels. The subscription provides both national and international news and current affairs that directly relates to the work of the department.
- b) The cost of the pay TV subscription is \$153.92 (GST inclusive) per month.
- c) Minister Ryan's office had access to the Foxtel for Business package for the period 14 September 2015 to 21 September 2015. Minister Hartsuyker's office had access to the Foxtel for Business package for the period 14 September 2015 to 17 February 2016. The TV subscription was not provided to Minister Birmingham or Minster Pyne during this period.
- d) For the period 14 September 2015 to 31 January 2016 the department paid \$292.05.
