HEPPP cuts

Question

What is the totality of cuts to the Higher Education Participation and Pathways program after the 2016-17 Budget?

- How many students will be impacted by the cuts to the HEPPP program?
- What is the impact on each university?

Answer

- \$553.2 million remains over that period to assist universities to provide pathways and support for students from low socio-economic status (low-SES) backgrounds.
- In the 2016–17 Budget, the Australian Government redirected \$152 million over the four years of the forward estimates from the Higher Education Participation and Partnerships Program (HEPPP) to fund priority initiatives and make a contribution to budget repair.
- Two of the HEPPP savings measures are ongoing beyond the forward estimates \$10 million per year to fund the Australian Institute for Aboriginal and Torres Strait Islander Studies (AIATSIS) collection and \$3 million per year to fund implementation of Australia's first National Strategy for International Education.
- The wide range of HEPPP-funded activities undertaken by institutions can include broad outreach and aspiration building with schools and higher education students in the target group. Accordingly, it is not possible to determine exactly the number of students who are currently impacted by the program, or the number who will be affected by the savings.
- HEPPP funding is distributed by formula, based on the proportion of all low-SES students enrolled at Table A institutions. The 2017 allocations have been calculated on the same basis as those for 2016 (see the attached table).
