These initiatives complement jurisdiction-based approaches that aim to deliver quality education to all students. The Australian Government works collaboratively with the states and territories, the Australian Curriculum, Assessment and Reporting Authority (ACARA), the Australian Institute for Teaching and School Leadership (AITSL) and Education Services Australia (ESA) through Education Council and other forums to implement them.

Program effectiveness is measured through contracted reporting requirements, including regular progress or milestone reports and final reports against project outcomes, and in some cases formal evaluations.
