Schooling Resource Standard - unchanged indexation rates

Question

For each school authority that is projected to receive more than 100% of its SRS in Commonwealth funding in 2018 list how many years it is projected to take for it to reach 100% if the indexation rates remains unchanged?

Answer

This information has not been modelled for 2018. However, it has been estimated for 2019 under the *Australian Education Act 2013* before the amendments announced in the *Quality Schools* package. The Government's *Quality Schools* reforms are subject to passage of legislation.

The table below presents estimates for each approved authority that is projected to be above the SRS in 2019 and their estimated additional years to transition from 2017. This analysis assumes annual state funding growth of 3 per cent, however there is no requirement in the *Australian Education Act 2013* for states to maintain funding.
