The table below shows the total estimated Commonwealth entitlement for each Approved System Authority in 2017 and how this funding relates (as a percentage of the Schooling Resource Standard or SRS) to the total funding each authority would have been entitled to receive had they not been subject to transition arrangements.

Figures are estimated entitlements as calculated under the *Australian Education Act 2013*. Final entitlements for 2017 are not calculated until after the schools census reference day in August 2017.
