Schooling Resource Standard

Question

Please provide a list of schools that currently receive (a) less than 60% of SRS, (b) less than 70% of SRS, (c) less than 80% of SRS.

What proportion of schools, by sector and by state receive (a) less than 60% of SRS, (b) less than 70% of SRS, (c) less than 80% of SRS.

Answer

Under current arrangements, funding is provided at the Approved Authority (AA) level rather than at the school level. The following tables provide information about the proportion of schools in AAs that meet the identified thresholds.

Data is based on 2017 estimated entitlements and derived from the department's payment system. The nominal Schooling Resource Standard (SRS) amount is the amount of funding the AA would have been entitled to receive under the *Australian Education Act 2013*, had they not been subject to transition arrangements. These estimates assume state and territory government funding has been provided to schools in line with the National Education Reform Agreement and Australian Government funding offers.
