Comparative performance of Australian students versus overseas students

Question

Senator SINODINOS: Without too much further work, there is information, I understand, available about the comparative performance of Australian students versus students overseas, whether it is through the OECD comparisons or others, and the linkage between funding and performance and what we can infer from that.

Mr Cook: I have provided evidence in the past around that. I have it here. We will certainly take it on notice where we talk to you about average per student costs per country and their PISA performance. We have that information. We will take it on notice.

Answer

Attachment A provides OECD information that compares Australia with other countries by the following criteria:

- Total public expenditure per student in 2011 for primary, secondary and post-secondary, non-tertiary (e.g. TAFE) education. Amounts shown are in equivalent US dollars converted using purchasing power parities (PPPs) for gross domestic product (GDP). This data is sourced from the OECD publication *Education at a Glance 2014*.
- Performance in 2012 Programme for International Student Assessment (PISA). This data is sourced from *PISA 2012 Results* — *Volume I* — *What students know and can do* (OECD 2014).


