FWO - Road Safety Remuneration Tribunal orders

Senator STERLE: Can you take on notice and just tell us what the complaints were? Are you able to do that?

Mr Campbell: We will probably be able to tell you the nature of them but probably not the parties.

Senator STERLE: Whatever you can do to provide the committee with the opportunity to go through and see what actual work has been done following on from complaints and referrals of the tribunal would be very helpful.

Answer

The Fair Work Ombudsman has a role to monitor and ensure compliance with the Road Safety Remuneration Act 2012 and enforceable instruments. The Fair Work Ombudsman is also responsible for educating workplace participants about the legislation. The first Road Safety Remuneration Order commenced on 1 May 2014.

As at 24 June 2015, the Fair Work Ombudsman has dealt with a total of 12 matters arising under this function. Three matters were referred from the Road Safety Remuneration Tribunal (RSRT) and nine were requests for assistance from the public:
