Students with Disabilities loading

Question

- What proportion of the SWD loading each year from 2017 to 2027 goes to (a) Government schools (b) Catholic systemic schools (c) independent schools?
- What proportion of the increase in funding for the SWD loading each year from 2018 to 2027 goes to (a) Government schools (b) Catholic systemic schools (c) independent schools?

Answer

The students with disability (SWD) loading is integrated into the calculation of funding entitlements and inextricably linked to the calculation of transition, base funding and other loadings. Therefore the amount provided is only notionally attributed to the loading. The SWD loading is not intended as funding earmarked to be spent on specific students; rather it enables schools to provide education to all students in a way that better supports students with disability. The Australian Government is continuing to consult on disability funding distribution and final settings are subject to regulations.

The government schools sector will attract more disability funding than the relevant share of total Commonwealth recurrent funding. For example, in 2018 government schools will attract 40 per cent of the total Commonwealth recurrent funding and 42.7 per cent of funding for students with disability.

Census SWD data is determined by whether a student meets the requirements of the state or territory in which the school is located for financial assistance to be provided in relation to the student as a student with disability. The 2017 census data on SWD will inform the final 2017 loadings, with any changes to funding reconciled with the final recurrent funding payments for the year, as per usual departmental processes.
