# 2. Detailed Cost of Legal Services

<sup>\*</sup>The internal hours taken to prepare advice by in-house lawyers are not available as not all lawyers in the department time record.

<sup>\*\*</sup>The cost of internal legal services is reported in line with the requirements set out in the Legal Services Directions 2005 and in the Australian National Audit Office's Best Practice Guidelines for Legal Services. They include all direct and indirect costs. Direct costs include salary, stationary, equipment and learning and development costs. Indirect costs include electricity, rent and other corporate overheads. The figures provided are also reported annually to the Attorney-General's Department.

## 3. Counsel/Barrister

The department has not incurred any costs for counsel/barrister fees in the 2014–15 financial year. Expenses incurred between 1 June – 30 June 2014 are outlined in the below table.

The department does not separately identify the cost of solicitors briefing counsel. In general, counsel/barrister's costs are by the day or half day, therefore total hours are not available. All matters briefed to counsel have been done so by the department. There have been no matters briefed by the minister.

#### 4. Procurement Process

External legal services were procured using the Attorney-General's Legal Services Multi-Use List (LSMUL) arrangements. Under the LSMUL agencies can establish parceling arrangements. Parcelling Deeds were entered into by the Department of Education, Employment and Workplace Relations in May 2013 and continue to apply to the Department of Employment.

The decision to engage external lawyers is made by either the Chief Counsel (Workplace Relations Legal) or General Counsel (Corporate Legal) taking into account the specifics of each individual matter.
