### Answer

- 1) Since Budget Estimates in June 2014 to 31 October 2014 Safe Work Australia spent \$3,064 on meetings (GST exclusive). Details of the meetings are:

  - 9 July 2014 Permanent Impairment Temporary Advisory Group meeting Safe Work Australia's premises in Canberra at a cost of \$36 for catering.
  - 24 July 2014 Strategic Issues Group (SIG) for Explosives meeting in the Department of Employment's Sydney premises at a cost of \$460 for catering.
  - 4 August 2014 Safe Work Australia SIG-Workers' Compensation meeting in the Department of Employment's Sydney premises at a cost of \$109 for catering.
  - 12 August 2014 Deemed Diseases Temporary Advisory Group meeting at Safe Work Australia's Canberra premises at a cost of \$81 for catering.
  - 15 August 2014 SIG-Work Health and Safety meeting at the Department of Employment's Sydney premises at a cost of \$681 for catering.
  - 18 September 2014 Safe Work Australia's Members' meeting at the Department of Employment's Sydney premises at a cost of \$802 for catering.
  - 17 October 2014 Australasian Reporting Awards meeting at Safe Work Australia's premises in Canberra at a cost of \$164 for catering.
  - 30 October 2014 SIG-Work Health and Safety meeting at the Department of Employment's Sydney premises at a cost of \$738 for catering.
