- 2. Grants are applied for as per the guidelines. The Agency also receives ad hoc requests for grants.

Safe Work Australia will be cautious about entering any sponsorship arrangement that may potentially expose the agency to risks including, but not limited to:

• creating potential or actual conflict of interests (e.g. sponsoring businesses that are likely to tender for future contracts)

• public perception of conflict of interest

• sponsors who may use the sponsorship arrangement to influence government, public policy or for any other purpose detrimental to Safe Work Australia's role or image, and

- associations or bodies with political objectives or affiliations.

- 5. Safe Work Australia's sponsorships and grants are approved at the CEO level. Consultation also involves the Senior Executive and in some cases Safe Work Australia Members.
