#### Question

## WGEA - Domestic violence support and training

Senator WATERS: That explains it for me. My last question is: how are the employers doing on the other measures which were included in the DV support category; that is not leave, per se, but things like staff training and other measures?

Ms Beattie: We are seeing small increases this year across most if not all of those measures, but again they are small.

Senator WATERS: If you could provide on notice as much information as you can about that. Ms Beattie: Yes. We will have the final data released on 26 November and we are still in the process of finalising all metrics.

Senator WATERS: Thank you very much for your help.

#### **Answer**

We are unable to provide comparisons between 2013–14 and 2014–15 reporting data as the 2014–15 data is not released until 26 November 2015.

The 2013–14 reporting data shows that while the majority of reporting organisations (37.8 per cent) did not have a domestic violence policy or strategy, 63.4 per cent provided access to an employee assistance program (Table 1).
