## FWO - Harvest Trail stakeholder engagement

CHAIR: Right. So how many producers did you speak to in the construction of this report. Ms James: In the construction industry—

CHAIR: No—not in the construction industry. We will take it back a step: of this class of migrant workers, what is the predominant industry they work in?

.....

CHAIR: No, I understand the Harvest Trail. You have put this report in the middle of your Harvest Trail inquiry, where you are actually engaging with community and you are engaging with industry groups—I would hope. We are making a lot of claims, that 92 per cent of the people affected are in agriculture, and I cannot—other than the meat-processing sector, which has very nice relationships with certain unions—see any horticulture. I cannot see any beef producers. Where is the UDV? Where are the Victorian Farmers Federation, AgForce, NSW Farmers or the National Farmers Federation? Where are they?

You come here and you tell us you have engaged with stakeholders and you want to cooperate with industry. Where are they? You do not know what there are even saying. You have not engaged appropriately. I am all for consultation. I absolutely abhor worker exploitation, wherever it occurs, and I was very disappointed when I got this report on Saturday that I could not find where you have engaged with the people that employ these workers. Please correct me.

Ms James: Senator, you are right in that, as part of this—we have had these two inquiries running in parallel and, when we announced each of them, we did also say what their duration would be. The Harvest Trail campaign was commenced a year ahead of this report, and, as part of that, we have talked to a range of people in the agricultural sector. CHAIR: Who? Can you provide us with a list?

Ms James: I am happy to take that on notice, to provide you with full list of who we have engaged with as part of the Harvest Trail campaign.
