Question

Breakdown of where new jobs have been created

Senator PATERSON: Could you also provide on notice a breakdown of where those new jobs have been created, both in a geographical sense, so which states and territories, and in an industry sense, so which industries have grown more or less than others. You may also have to take this on notice, but I wonder whether or not you can provide what the full-time jobs growth rate is currently.

Mr Neville: It depends on what period you are looking at.

Senator PATERSON: What is a reasonable period to look at? What is a useful period for us? Mr Neville: We would say three to five years. These numbers do jump around a bit. We have new numbers coming out tomorrow, and the story could be quite different.
