Question

FWBC - Travel by Director of FWBC

Mr O'Keeffe: The records do go through our books. We have supplied to the Senate before information where you have asked, for example, 'Has Mr Hadgkiss travelled to Hobart?' He has given you that information. We have looked it up. It has been in the—

Senator CAMERON: Can you do that again? Mr O'Keeffe: We know where to find that.

Senator CAMERON: Can you do that again for the period from the last time you provided that information to the present? Can you also ensure we know what that funding was expended for, not just that he went to Hobart and stayed in such a hotel? I want to know where he went, how much was expended, whether there was any entertainment expenses. I want to know that. Also, I want to know why he undertook that travel. And I want to know who

he met when he undertook the travel.

Senator MARSHALL: And can you dip into the funds enough to buy the man a diary?

Senator CAMERON: Can that be done?

Mr O'Keeffe: I will take that on notice, as you have asked.

Senator CAMERON: I am not asking you to take it on notice. I am asking you to provide the information.

CHAIR: But he will have to take it on notice, Senator, to do that because he does not have it with him.

Mr O'Keeffe: Correct.

Senator CAMERON: So I want that information—absolutely. Do you understand your

obligations to the Senate, Mr O'Keeffe?

Mr O'Keeffe: Yes, Senator.

Senator CAMERON: What is that obligation in terms of providing information to the Senate?

Mr O'Keeffe: To provide the information that is available. Senator CAMERON: So that information is available?

Senator Cash: He said he would take it on notice.

Mr O'Keeffe: I will need to see what information is available there so I can provide it to you.

Senator CAMERON: So does anyone—

Mr O'Keeffe: I cannot give you a guarantee for the exact amount of detail that is there. And I provided you last time with the information that was available.

Senator CAMERON: Yes, I am asking for that again. But I am also—

Mr O'Keeffe: So that is the degree of detail that was available. I will be able to do the same again.

CHAIR: Thank you, Mr O'Keeffe. You have taken it on notice. Thank you for that. Senator CAMERON: Are you aware of why Mr Hadgkiss travels and who he meets?

Mr O'Keeffe: Not necessarily.

Senator CAMERON: So I want that information. Can you provide that information, Mr Hadgkiss? If Mr O'Keeffe, the chief operating officer, does not know what you are doing, can you ensure that he does know and that the Senate knows what you are doing?

Mr Hadgkiss: I will take it on notice, Senator. CHAIR: Mr O'Keeffe is taking it on notice.
