- b-c. The department is unable to release the details associated with the resignation due to the need to protect the privacy of the individual concerned.
- d. Since January 2008.
- e. The resignation took effect on 10 September 2010.
- f. Prior to the person's resignation there were two full-time chefs working at The Lodge. The person appointed to the vacant chef position undertakes chef and house attendant duties.
- g. The position was not advertised.
- h. An applicant who was qualified for the combined role was sourced without advertising. That person was interviewed by Mr John Cairns, former First Assistant Secretary, Ministerial Support Unit and the former House Manager and current Senior Chef. Having been found to be suitable for the position, the candidate was appointed to The Lodge staff.
- 4. No.
- 5. The Lodge has four full-time and one part-time staff members. Kirribilli House has two full-time staff. The Lodge is generally staffed between 6am and 10pm seven days a week when the Prime Minister and Mr Mathieson are in residence. Kirribilli House is generally staffed between 9am and 6pm, Monday to Friday, and when the Prime Minister and Mr Mathieson are in residence.

Duties – House Manager, The Lodge

The House Manager undertakes a custodian/managerial role for the Prime Minister's Official Residence, The Lodge in Canberra. The role involves being accountable for the day-to-day operation of The Lodge subject to the direction and guidance of the Department. This involves assisting and

supervising the tasks and duties required to maintain the residence, and facilitating urgent requests, repairs and maintenance, as required.

*Duties – Senior Chef, The Lodge* 

The Senior Chef is responsible for the efficient management and operation of the kitchen at the Prime Minister's Official Residence, The Lodge in Canberra. This involves preparing menus, including wine selection, and providing high quality meals for the occupants and functions for up to 400 guests.

Duties – House Manager/Head Chef, Kirribilli House

The House Manager/Head Chef undertakes a custodian/managerial role for Kirribilli House which involves being accountable for the day-to-day operations of the residence subject to the direction and guidance of the Department, and is also responsible for the efficient management and operation of the kitchen.

Duties – House Attendant, The Lodge and Kirribilli House

The House Attendants support the House Manager/Head Chef in the day-to-day operation of the Prime Minister's Official Residences, The Lodge in Canberra and Kirribilli House in Sydney. This involves providing personal domestic and cleaning services as well as table service for meals and functions.

- 6-7. The Houses were staffed in accordance with the requirements outlined above.
- 8. The total running costs for the Official Establishments for the period 1 July 2010 to 28 February 2011 was \$783,137 for The Lodge and \$494,609 for Kirribilli House.
- 9. Staff may work additional hours for private functions if the function cannot be serviced within normal working hours.

- 10. The details of, and guest lists for, official functions from May 2008 (when the department first released guest lists for official functions) until the end of February 2011 are attached. Under long-standing arrangements the department does not release information on private functions.
- 11. The department cannot provide copies of all staff rosters since 2006 as this would require an unreasonable diversion of resources.
- 12-15. There is no 'men's shed' in the grounds of Kirribilli House.
- 16. The vegetable garden remains in place at The Lodge. The chicken coop was removed privately by the Rudd family at no cost to the department.
